- I understand that advisor error is not an acceptable reason for taking classes not applicable to my degree program.
- I must notify the Veterans SCO at TRC if I make changes in my registration. This includes dropping or adding classes and withdrawal from school. Changes in course enrollment may result in the retroactive loss of benefits unless the VA finds mitigating circumstances involved in the change. This could also result in monies owed.
- I must attend class and make satisfactory progress in accordance with Three Rivers College Satisfactory Academic Progress guidelines to be eligible for certification of my benefits.
- I understand it is in my best interest to speak with the Veterans School Certifying Official to go over my schedule.
- Students using Chapters 30, 33, or 1606 benefits are required to verify attendance monthly with the VA. *Opt-In to complete via text messaging: OR by phone at 1-877-823-2378. Chapter 35 dependents that are seeking a Certificate (not an Associates Degree) are required to verify attendance monthly with the VA.
